**ANY ROAD DAMAGE DUE TO CONSTRUCTION MUST BE REPAIRED BY THE PROPERTY OWNER WITHIN 30 DAYS OF THE END OF CONSTRUCTION. FAILURE TO DO SO WILL CAUSE FOX TRAIL PROPERTY OWNERS ASSOCIATION TO HAVE IT REPAIRED AT THE PROPERTY OWNER'S EXPENSE. IF YOU FEEL THAT THERE IS PRE-EXISTING ROAD DAMAGE, YOU MUST SUBMIT A PHOTOGRAPH SHOWING THE DAMAGE PRIOR TO BEGINNING CONSTRUCTION THAT SHOWS THE DAMAGE AND THE LOCATION.**

**ARTICLE II, SECTION 12, COVENANTS & RESTRICTIONS: THE NATURAL FLOW OF WATER SHALL NOT BE INTERRUPTED BY A PROPERTY OWNER OF THE ASSOCIATION HAVING PROPERTY ELEVATED SO THAT WATERFLOW IS OBSTRUCTED OR RETARDED, CAUSING A CLEAR AND PRESENT DANGER OR POTENTIAL DANGER OF HEALTH AND SAFETY TO OTHER RESIDENTS OR PROPERTY OWNERS OF THE ASSOCIATION BECAUSE OF FLOODING OR OTHER WATER RELATED DAMAGE.**

- 3. A CURRENT SURVEY SHOWING WHERE THE NEW CONSTRUCTION WILL BE LOCATED ON THE PROPERTY.**
